As an identified stakeholder I would be grateful if you can see below an informal consultation process on the proposals to amend the Public Space Protection Order (PSPO) relating to dog control. We would welcome your input.

**Public Consultation on the making of a Public Spaces Protection Order Relating to Dog Control**

Caerphilly County Borough Council is inviting local people to have their say on the proposal to amend the Public Spaces Protection Order (PSPO) relating to dog control in Caerphilly County Borough to include the exclusion of dogs from marked sports pitches/areas.

In 2017 Cabinet approved and adopted the Public Spaces Protection Order 2017 for a period of three years. This was subsequently extended for 1 further year in October 2020.

The new proposed Order includes the following restrictions:

- Excluding dogs from all enclosed children's play and multi-use games areas
- Requiring dogs to be kept on leads in enclosed memorial gardens
- Requiring dog owners to remove dog faeces in public places
- Requiring dog owners to carry an appropriate receptacle for dealing with the waste that their dogs produce (that is to always have the means to pick their dog faeces)
- Requiring dog owners to put their dogs on a lead when directed to do so by an authorised officer on any public land where the dog is considered to be out of control or causing harm or distress to prevent a nuisance.
- In addition to the above the Council propose to make it an offence if a person in charge of a dog takes the dog on to, or permits the dog to enter or remain on, any of the marked playing pitches/areas in appendix of the order.

The public consultation will start on \_\_\_\_\_ 11<sup>th</sup> June 2021 for a period of 10 weeks. To take part, please complete our survey.

Mae Cyngor Bwrdeistref Sirol Caerffili yn gwahodd pobl leol i ddweud eu dweud ar y cynnig i ddiwygio Gorchymyn Diogelu Mannau Agored Cyhoeddus o ran rheoli cŵn ym Mwrdeistref Sirol Caerffili i gynnwys eithrion o gaeau/meysydd chwaraeon wedi'u marcio. Yn 2017, cymeradwyodd a mabwysiadodd y Cabinet y Gorchymyn Diogelu Mannau Agored Cyhoeddus 2017 am gyfnod o dair blynedd. Yn dilyn hynny, cafodd ei ymestyn am flwyddyn arall ym mis Hydref 2020.

Mae'r Gorchymyn arfaethedig newydd yn cynnwys y cyfyngiadau canlynol:

- Eithrio cŵn o bob man chwarae amldeffnydd ac ardal chwarae caeedig i blant
- Mynnu bod cŵn yn cael eu cadw ar dennyn mewn gerddi coffa caeedig
- Mynnu bod perchnogion cŵn yn cael gwared ar faw ci mewn mannau cyhoeddus
- Mynnu bod perchnogion cŵn yn cario cynhwysydd priodol ar gyfer ymdrin â'r gwastraff y mae eu cŵn yn cynhyrchu (hynny yw, bod modd iddynt godi baw eu cŵn ar bob adeg)
- Mynnu bod perchnogion cŵn yn rhoi eu cŵn ar dennyn pan fydd swyddog awdurdodedig yn eu cyfarwyddo i'w gwneud ar unrhyw dir cyhoeddus lle ystyrir nad yw'r ci o dan reolaeth neu'n achosi niwed neu ofid er mwyn atal niwsans.
- Yn ychwanegol at yr uchod, mae'r Cyngor yn cynnig ei wneud yn drosedd os yw person â gofal ci yn mynd â'r ci ymlaen i, neu'n caniatáu i'r ci fynd i mewn i unrhyw un o'r caeau/meysydd chwarae wedi'u marcio neu aros arno yn atodiad y gorchymyn.

Bydd yr ymgynghoriad cyhoeddus yn dechrau ar 11<sup>th</sup> Mehefin 2021 am gyfnod o 10 wythnos. I gymryd rhan, cwblhewch ein harolwg.
